NOTICE OF ANNUAL BUDGET HEARING AND SEPARATE BUDGET VOTE AND ELECTION TOWN OF WEBB UNION FREE SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN that the Annual Budget Hearing the inhabitants of the Town of Webb Union Free School District will be held at the schoolhouse on Main Street, Old Forge, New York, in said district on the 13th day of May, 2008 at 7:00 p.m. for transaction of such business as authorized by law. A separate budget vote and election of the inhabitants of the Town of Webb Union Free School District, qualified to vote at school district meetings/elections in said school district, will be held at the schoolhouse on Main Street, Old Forge, New York, in said district the 20th day of May, 2008, between the hours of 2:00 o'clock p.m. and 9:00 o'clock p.m. for the purpose of voting upon:

- 1. The adoption of the 2008-2009 School District Budget to be raised by tax upon the taxable real property of the district.
2. Candidate for a seat on the Board of Education - 4 year term.
3. Candidate for a seat on the Board of Education - 5 year term.
4. A proposition authorizing the Board of Education of the Town of Webb UFSD to undertake a project to construct a new storage building, demolish the existing Case Building and convert an existing classroom to a new principal's office and develop a secure entry point, and to expend therefore a gross sum not to exceed \$200,000 or so much thereof as may be necessary, and to pay for such improvements with unappropriated fund balance, all at no additional taxes to the district residents.
5. A proposition authorizing the Board of Education of the Town of Webb UFSD to increase the annual levy of taxes upon the real property of the district to meet the annual operating cost of the Old Forge Library by an amount of \$35,000 for a total annual appropriation of \$110,000, to be paid to the Trustees of said library.

AND NOTICE IS ALSO GIVEN that a copy of the statement of the amount of money which will be required to fund the school district budget for the ensuing year for school purposes, will be available at the District Office in the schoolhouse located on Main Street, Old Forge, New York, during normal business hours between 8:00 o'clock a.m. and 3:00 o'clock p.m. during the fourteen (14) days immediately preceding the annual meeting and election, except Saturday, Sunday, or holidays.

AND NOTICE IS FURTHER GIVEN that petitions nominating candidates for the office of member of the Board of Education must be filed with the District Clerk between the hours of 8:00 a.m. and 5:00 p.m. not later than thirty (30) days preceding the school meeting or elections at which the candidates are to be elected.

The following vacancy is to be filled on the Board of Education:
(Term) 4 year term (last incumbent) Kathleen Nahor commencing July 1, 2008
(Term) 5 year term (last incumbent) Patricia Josephson commencing July 1, 2008

Petitions must be directed to the Clerk of the District, must be signed by at least twenty-five qualified voters of the district or two (2) percent of the voters who voted in the previous annual election of members of the Board of Education, whichever is greater, such numbers to be determined by the number of persons recorded on the poll list as having voted at such elections, must state the residence of each signer, must state the name and residence of the candidate, must describe the specific vacancy for which the candidate is nominated, including at least the length of term of office and the name of the last incumbent, if any. Blank petitions may be obtained in the District Office of the School District. Candidate expenditure statements required by Education Law Section 1528 are to be filed as follows: The first statement must be filed on the tenth day preceding the election and the final statement on the twentieth day following the election.

AND FURTHER NOTICE IS HEREBY GIVEN that applications for absentee ballots for election of school board member(s), adoption of the annual budget & referenda may be applied for during school business hours. Completed applications must be received by the District clerk at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election, if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the District Clerk no later than 5:00 p.m., prevailing time, on the day prior to the election.

A list of persons to whom absentee ballots are issued will be available for inspection to qualified voters of the District in the office of the District Clerk on each of the five days prior to the day of election, between the hours of 9:00 a.m. and 4:00 p.m. on weekdays prior to the day set for the annual election and said list will be posted at the polling place at the election. Any qualified voter present in the polling place may object to the voting of the ballot upon appropriate grounds for making his/her challenge and the reasons therefore known to the Inspector of Election before the close of the polls.

BOARD OF REGISTRATION MEETING

THE BOARD OF EDUCATION OF THE TOWN OF WEBB UNION FREE SCHOOL DISTRICT has duly adopted personal registration pursuant to Section 2014 of the Education Law. If a voter has heretofore registered pursuant to Section 2014 of the Education Law and still is domiciled within the school district, he/she is eligible to vote at this election; if a voter is registered and eligible to vote under Article 5 of the Election Law, he/she is also eligible to vote at this election. All other persons who wish to vote must register. Notice is hereby given that the Board of Registration shall meet in the high school library of the schoolhouse of said district located at Main Street, Old Forge, New York on the following dates and times:

NOTICE IS FURTHER GIVEN that the Board of Registration shall meet during the annual election for the purpose of preparing a register for meetings or elections subsequent thereto. Any person is entitled to have his or her name placed on such register, provided, at such time, he or she is known or proven to the satisfaction of said Board of Registration to be then or thereafter entitled to vote at such election. All persons registering upon the election date shall be eligible to vote at all district meeting held thereafter but not at such election.
